#### If you have not used the DfE Manage Training for ECTs service before

If registering your first ECT since the 2021 changes to statutory induction and using the DfE portal for the first time, you may need to request a link to use the service. You can request a link here:

It is usually the **Headteacher** or **Induction Tutor** who registers the school's ECTs and mentors.

Whoever is registering will find it useful to have the following information to hand:

- The school's URN and postcode
- Full name, TRN and e-mail address of all ECTs and mentors being registered
- Full name and e-mail address of the Induction Tutor
